

RESERVATION PROCEDURES

POWDERHORN PARK AND WINDJAMMER PARK

1. RESERVATIONS WILL BE MADE THROUGH Campbell Property Management for Loggers' Run residents only, at (561) 451-9992 for such use and will be handled on a first come, first served basis.
2. An agreement application and \$ 50.00 money order deposit payable to **CASH** is required. Your \$ 50.00 money order will be returned to you as long as the area which you have reserved has been restored to its original condition and all rules have been obeyed appropriately.
3. Contact security the day and time of your reservation, to sign a before and after waiver regarding your reservation. Security is required to observe the area!
4. The area is to be reserved by **LOGGERS' RUN RESIDENTS ONLY**.
5. Your deposit will be returned to you within a week after the date of use, **if** the area has been returned to its original condition and all rules have been followed.
6. You will be required to pick up your money order deposit at the Loggers' Run Management office and sign a release that you have received your deposit at Campbell Property Management's Loggers' Run office.
